The above-captioned matter came before the Court for sentencing on September 3, 2004. Paul E. Dame, Deputy Washington County Attorney, represented the plaintiff. The defendant, RULON JOHNSON STEED, was present and represented by Kenneth L. Combs. As the defendant had previously been found guilty of the charge of: SEXUAL ABUSE OF A CHILD, a 2nd degree felony, both counsel made their recommendations to the Court regarding sentencing. The Court, having received and read a Presentence Investigation Report from the Department of Corrections, and having reviewed the files and records herein and being fully advised in the premises, now makes and enters the following Judgment, Restitution Judgment, Sentence, Recommendation, and Commitment:

JUDGMENT

IT IS HEREBY FOUND that the defendant, RULON JOHNSON STEED, is guilty of the offense of: SEXUAL ABUSE OF A CHILD, a 2nd degree felony.

RESTITUTION JUDGMENT

IT IS HEREBY FOUND, upon the Court's consideration of the statutory criteria, pecuniary damages were incurred as a result of the criminal activity of the defendant, and that restitution is appropriate in this case.

IT IS HEREBY ORDERED, that a Restitution Judgment is awarded in favor of the victims and against the defendant as follows: Medicaid in the amount of \$2,500.00, plus interest at the State rate.

SENTENCE

IT IS HEREBY ORDERED that the defendant, RULON JOHNSON STEED, shall serve a minimum of one (1) year to a maximum of fifteen (15) years in the Utah State Prison.

RECOMMENDATION

THE COURT HEREBY RECOMMENDS that the defendant engage in and participate in sex-offender treatment and therapy. Because of the defendant's prior offenses and his denial, the Court finds that the defendant constitutes a clear and present danger to little girls in society. The Court therefore recommends that the defendant complete sex-offender therapy and treatment before being paroled.
